## NEW SIGNS FOR A NEW FENCE IN THE NEW YEAR

The Board is researching new entrance signs for Sand Pebbles, Captains Run and Quarry Lane. As most of you know we held a design submission period last summer so that all residents would have an opportunity to present an idea on paper for the project. Unfortunately, we did not receive anything on paper but the general feedback from discussions among neighbors was to have something that would be similar to the old signs or like the design we had for the Lake Christopher T-shirts. We had a sign company, **Signs By Tomorrow**, come and give us an estimate for signs very similar in size and shape to the old ones to give us an idea of how much money we were looking at.. The price came in a bit high but it was a good start for our research.

Since then, Elias Logothetis, one of our board members has been working on getting this visual ready for you to see and make comments. We think we have a visual for our entrances of which we can all be proud.



The overall width and height of sign is 84"x34-1/2". The rectangular panel dimensions are 84" wide by 28" high. Logo diameter is 20-1/2". Letter height is 8". Overall sign thickness is 1" high density urethane sign foam. Sign background is in blue, routed to give the appearance of wood grain. Logo and lettering are in white. The signs are sturdy and permanent but light enough to be attached to the fence.

We look to send out solicitations for bids in January; we would appreciate any comments or suggestions be submitted in writing to the property manager's office by the end of this month.

**ANNUAL ASSESSMENTS**

The annual dues assessments will be mailed to you shortly along with a copy of the 2011 Budget. Payment in full is due by January 1<sup>st</sup>.

If payment is not received by January 31<sup>st</sup>, a late fee will be added to the amount owed.

Please make sure you do not overlook the assessment letter from the Select Group.

Your neighbors are counting on you to have the payment in on time.

Members of LCHA will be denied voting privileges at the Annual Meeting and access to the parks if dues are not paid.

Renters: the assessment bill for your property will be sent to the owners of the house or their agent. You will, however, be denied access to the parks this summer if the assessment is not paid

## Financial Disclosure

### Assessments

- Notice of annual assessments is distributed by first class mail in December and payment is due in full by January 1.
- Notice will be given not less than 30 or more than 60 days prior to any increase in regular assessments or special assessments.
- Notice of an additional late fee of \$10.50 will be mailed to the homeowner if assessment is not received by January 31.
- Legal remedies for collecting delinquent assessments will be applied if payment is not received by March 1.

### Budget

A summary of the approved Budget is distributed annually along with assessment notices.

### Financial Statement

- All members in good standing may review any financial statements, insurance coverage, and Minutes of Board of Directors meetings at the office of the Property Manager by appointment.
- Any copies required by the member shall be at the member's expense.

## Do Foreclosures Really Impact Home Prices?

Foreclosures have had a tremendous impact on housing prices on the market. This past year, Lake Christopher residents have felt this decreasing of values to their Properties as Foreclosed Homes bring lower and lower selling prices.

Here is what **The Wall Street Journal** reported in an article on Sept 13<sup>th</sup> ....

The speed at which house prices fall over the next few months could depend less on mortgage rates and Americans' appetite for home buying than on how banks decide to manage the huge number of foreclosed homes they own or may take from delinquent borrowers in the near future. **Unlike home owners, banks often are much quicker to slash prices to unload properties quickly. The upshot is that, the more homes being sold by lenders, the faster prices tend to fall.**
